

New Playground at CLC William Pitt Transforms Playtime for Stamford's Youngest Learners

Last fall, we held a ribbon-cutting ceremony for our new playground at CLC William Pitt, the largest of CLC's six early childhood education centers in Stamford. This event celebrated the creation of a new state-of-the-art playground that will serve more than 340 children, providing a safe, engaging, and developmentally enriching space for play and learning.

More than \$500,000 was raised from individual donors, foundations, and local and state public entities, including The Herbert and Nell Singer Foundation, the City of Stamford, and the State of Connecticut Office of Early Childhood ARA grant who made this project possible.

Education

Shaping the Future, Today!

At CLC, we implement *The Creative Curriculum*[®], a research-based, whole-child framework that nurtures children's social, emotional, cognitive, and physical development through play-based learning. Through hands-on, project-based studies on engaging, real-world topics — such as wheels, trees, and buildings — children experience learning that is both joyful and meaningful.

In partnership with Stamford Public Schools, we align curriculum units and professional development to ensure consistent, developmentally appropriate learning experiences across settings. This collaboration supports smoother transitions into kindergarten and promotes stronger outcomes for every child.

By integrating best practices, promoting academic readiness, and fostering social-emotional growth, CLC builds a powerful foundation for lifelong success. Our work also deepens family engagement and strengthens the broader Stamford community.

Accessible Programs for All Families

CLC offers free Early Head Start and Head Start programs for income-eligible families in Stamford, Darien, and Greenwich. Extended hours are available for a nominal fee. In addition, we provide statesubsidized preschool programs with a sliding fee scale set by the Connecticut Office of Early Childhood (OEC), ensuring access to highquality early education for all.

Empowering Educators: CLC's Career Ladder Program

With the generous support of the **Synchrony Foundation**, CLC's Career Ladder Program continues to play a pivotal role in advancing the professional growth of our educators while strengthening the quality of care and education we provide to families.

This initiative is vital to CLC's ability to meet state and federal licensure requirements, which are essential for maintaining government funding and addressing a critical gap in affordable childcare.

Thanks to Synchrony's funding, **33 women** have been empowered to pursue higher education and credentialing opportunities that enhance their skills, support their continued employment, and increase their earning power. These achievements are not only life-changing for the participants — they also enrich the learning experiences of the children in our programs.

- 1 teacher is working toward an **Associate in Science Degree**

- 6 teachers are working to renew their CDA
- 6 teachers are newly enrolled in a CDA program

Family Services

Empowering Families, Strengthening Communities

CLC provides holistic support for students and families through admissions, social work, nutrition, health services, basic needs assistance, and mental health resources. Our Family Services Team offers wrap-around care, linking children with developmental or behavioral needs to appropriate community services. We also empower parents to advocate for their children and connect families with resources such as food, emergency support, and English Language Learner (ELL) classes.

Mental Health Partnership

CLC has a robust partnership with the Child Guidance Center of Southern Connecticut (CGC) to promote infant and early childhood mental health. Research underscores the value of early intervention, and together we offer a range of services to children and families, including:

• Classroom-focused mental health consultation, which includes observation and collaborative reflective consultation sessions with teachers

- On-site child, family, dyadic (child-caregiver), and group counseling during the school day with CGC clinicians
- Parent guidance sessions (in person, by phone, or virtual)
- Streamlined access to clinic-based therapy and CGC's range of programs

CGC clinicians also provide child-focused mental health consultation to all CLC preschool classrooms, offering tailored strategies to support each child's unique social, emotional, mental health, and developmental needs. Each preschool-based CGC Clinician is formally trained in at least one early childhood indicated, evidence-based trauma intervention model.

This impactful collaboration is funded by federal grants, a SAMHSA infant and early childhood mental health grant and private philanthropy. Together, we help remove barriers to care and support children's development at home and at school.

Health Services

Supporting Student Well-Being

Our health services play a vital role in ensuring our children are safe, supported, and ready to learn. Whether it's a scraped knee that needs gentle care or a thoughtful conversation with a parent about managing a medical condition at home, our nurses are there — bringing compassion and expertise to every interaction. They track immunizations and provide essential care when illness or injury occurs during the school day. Their presence is a constant source of reassurance for students and families alike.

Nutrition

Healthy Starts

We provide free daily breakfast, lunch, and snacks to all CLC children, adhering to the highest federal and state regulations. Our team works closely with families to accommodate a variety of cultural and dietary restrictions so every child has the nutrition they need to learn and thrive. Our staff nutritionist also provides assessments, allergy monitoring, and nutrition counseling to families.

Providing these healthy meals costs CLC nearly \$1 Million each year. That's a significant but necessary investment. Research shows that free school meals help young children with improved brain function and learning, reduce food insecurity at home, and help build strong growing minds and bodies.





No child can learn on an empty stomach. Every day, our Nutrition team steps up with one goal in mind: to ensure that every child is not only fed, but truly nourished. What makes our work so important is the way we collaborate with medical professionals, staff, and parents to create a personalized, child-centered nutrition plan. We're here to listen, adapt, and make eating fun — whether through interactive nutrition workshops or shared meals.

Challenges like language barriers, cultural differences, and special dietary requests come up, but nothing stands in the way of our commitment to providing meals that are not only nutritious but also inclusive. We thrive on supporting families, offering expert guidance in food safety, lactation counseling, and personalized consultations. And we're always just a call away, ensuring every family feels seen and heard. For us, food isn't just about filling bellies — it's about fueling young minds, fostering growth, and building lifelong healthy habits. 

I first came to CLC not as a teacher, but as a parent looking for support. I joined the Parenting Journey group, which met every Tuesday, and it truly changed my life. It was a space where parents — many of us with children at CLC — came together to share our stories, struggles, and hopes. I started to feel more confident, more seen, and more understood. They encouraged me to look into job

opportunities at CLC, and I decided to try. I started as a substitute teacher... and I fell in love with it.

Today, I'm proud to say I work at CLC. Being here — first as a parent and now as a teacher — has been one of the most transformative experiences of my life. I've learned to be more open, more present, and more connected.
